Order:

Pursuant to section 38(1)(c) of the *Energy Resource Activities Act* (the Act), I, Kevin Parsonage, order that Pavilion Energy Corp. (Pavilion) must:

1. For each survey completed in accordance with section 41.1 of the Drilling and Production Regulation (DPR), prepare a record for each well listed in Schedule A and for each facility listed in Schedule B of the information required by section 41.1(7) of the DPR for the calendar year 2023.
2. For each facility listed in Schedule B, prepare a record indicating the number of days each facility was active during the calendar year 2023.

Request:

Pursuant to section 38(1)(e) of the Act, the BCER requests that Pavilion submit a copy of the records referred to in items 1 and 2, by no later than July 8, 2024, electronically to C&E@bc-er.ca.
