Metadata for **CARIBOU MGMT ZONES PY**



Purpose

The Boreal Caribou Protection and Recovery Plan Management Zones (CARIBOU_MGMT_ZONES_PY) delineate four management types for boreal caribou habitat in the Boreal Caribou Protection and Recovery Plan (BCPRP) area.

Background

Management Type 1 has been added to the BCER regulatory review process to recognize this top restoration priority and promote full habitat protection across all industries.

The following table, extracted from Boreal Caribou Protection and Recovery Plan (2022)¹, describes the intent and measures of the management types. Note that these zones are not legal orders on their own, they are meant to guide future legal orders and management actions to align with the intent.
