Purpose

The Orphan Pipeline (ORPHAN_PIPELINE) lists all designated pipeline orphan sites - each of which only contains pipeline segment(s) – and their current decommissioning and restoration progress (status).

Background

Orphan pipeline sites contain pipeline segment(s) only, where any disturbance and associated permits are grouped as a unique site for restoration tracking purposes. As decommissioning and restoration activities are completed under the Orphan Site Reclamation Fund (OSRF) the site status advances accordingly. This progression provides assurance the site will be restored in accordance with current standards and requirements, and all known contamination risks or hazards have been addressed.
