**RE: APPLICATION FOR COMMINGLED PRODUCTION
ANADARKO PRESPATOU A-38-B/94-H-3; WA# 9402**

The Commission has reviewed your application dated October 10, 2000, requesting permission to commingle gas production from the Gething and Baldonnel zones encountered in the subject well.

The Commission has designated the gas pools under application to be the Prespatou – Gething “A” and Baldonnel “A”. Both pools contain mainly sweet gas. Commingled production is expected to increase gas production from otherwise marginal zones by mitigating liquid loading problems. This would increase the producing life of the well, thereby increasing recoverable reserves. Your proposal to isolate the pools to prevent potential crossflow during lengthy shut-in is considered appropriate.

We wish to advise you that your application to commingle production from these two pools is hereby approved, under the authority of section 41 of the *Drilling and Production Regulation*, subject to the following conditions:

1. Production from the Gething (1148.0–1153.0 mKB) and Baldonnel (1194.5–1212.0 mKB) zones may be commingled.
2. Gas, condensate and water production should be allocated on the Ministry of Energy and Mines BC S-1 and BC S-2 forms on the basis of Gething 80% and Baldonnel 20%.
3. This approval may be modified at a later date if deemed appropriate through a change in circumstances.
