**RE: APPLICATION FOR COMMINGLED PRODUCTION APPROVAL  
Devon ARL Hiding d-52-F/93-I-16; WA# 13908**

The OGC has reviewed your application dated April 8, 2004, for approval to commingle gas production from two separate Notikewin formations in the subject well.

The Commission has designated the gas pools under application to be the Hiding Creek – Notikewin “A” and Notikewin “B” pools. Currently both zones are commingled via a leaking sliding sleeve and have been producing in a partially commingled fashion since October 2003. Both zones are capable of sustained economic production when produced in a segregated manner. Although spring break-up makes access to this location temporarily impractical, the Commission does not believe that this well is a feasible candidate for commingled production. The Commission will allow the well to continue producing with its current configuration until the earliest opportunity that road conditions permit access, at which time the leaking sliding sleeve must be repaired and zonal isolation re-established.

Additionally, our records show that a reservoir pressure survey has not been performed on either of these zones since commencement of production in December 2001. Therefore once segregated production has been restored the Commission requests a pressure survey test on each zone, as per Section 95 of the *Drilling and Production Regulations*.

The Commission would also like to take this opportunity to remind Burlington of its commitment to submit amended BC-S1 reports for the subject well, pro-rating production back to the proper zones.
