**RE: APPROVAL FOR COMMINGLED PRODUCTION, AMENDMENT #1
CNRL ET AL FIREWEED a-81-A/94-A-13; WA# 3758**

The Commission has reviewed your application dated August 31, 2000, requesting permission to commingle gas production from the Bluesky and Dunlevy zones encountered in the subject well.

Attached is a copy of an approval granted to Blue Range Resource Corporation dated March 13, 1998, granting approval to commingle the Bluesky "B" and Dunlevy "D" pools encountered by this well. However, based on recent production test data and reserves projections provided in your application, allocation factors are revised. Therefore, we wish to advise that the approval to commingle production is hereby amended, under the authority of section 41 of the *Drilling and Production Regulation*, subject to the following conditions:

1. Production from the Bluesky (1157.0 – 1161.9 mKB) and Dunlevy (1197.2 – 1240.5 mKB) zones may be commingled.
2. Gas, condensate and water production should be allocated on the Ministry of Energy and Mines BC S-1 and BC S-2 forms on the basis of Bluesky 75% and Dunlevy 25%.
3. This approval may be modified at a later date if deemed appropriate through a change in circumstances.
4. This approval is retroactive to the date that commingling occurred in September 1999, as such, amended S reports must be submitted where required to properly allocate production.
