**RE: COMMINGLED PRODUCTION APPROVAL  
CNRL WEASEL a-84-B/94-H-02; WA# 15482**

The Commission has reviewed your application dated March 5, 2007 requesting permission to commingle gas production from the Bluesky and Halfway formations in the subject well.

The Commission designates the gas pools under application to be the Weasel field – Bluesky “B” and Halfway “N”.

Both pools have been mapped as two well pools. The Bluesky in the subject well has been on production since April 2004 and is currently producing at  $6.0 \times 10^3 \text{ m}^3/\text{d}$ . The Halfway in the subject well came on production in April 2003, however due to liquid loading and operational issues this zone has not effectively produced since June 2005. The Halfway zone in the subject well showed significant depletion upon completion, suggesting a very limited reservoir extent. The last know production rates for the Halfway was less than  $10.0 \times 10^3 \text{ m}^3/\text{d}$ . Commingled production through a single coil string is expected to maximize production and reserve recovery from both zones. CNRL is the operator of all wells in these pools.

We wish to advise that your application to commingle production from these zones is hereby granted approval, under the authority of Section 41 of the *Drilling and Production Regulation*, subject to the following conditions:

1. Production from the Bluesky (1006.0 – 1008.5 mKB) and Halfway (1125.0 – 1126.5 mKB) zones may be commingled.
2. Gas, condensate and water production should be allocated on the Ministry of Small Business and Revenue BC S-1 and BC S-2 forms on the basis of Bluesky 50 % and Halfway 50 %.
3. This approval may be modified at a later date if deemed appropriate through a change in circumstances.



We note that two wells (a-74-B and a-84-B/94-H-02) are completed within a gas spacing unit (GSU) for gas production from the Bluesky "B" pool. Please note that normal gas well spacing and target restrictions specified under Section 10 of the *Regulation* continue to apply, unless a Good Engineering Practice (GEP) is approved under Section 101. Therefore, only one well is entitled to be produced from the GSU at this time.
