**RE: INTERIM APPROVAL FOR COMMINGLED PRODUCTION  
BRC HTR et al Hiding a-28-G/93-I-16; WA# 15494**

The Commission has reviewed your application dated November 29, 2005, submitted on behalf of Burlington Resources Canada Limited, for interim approval to commingle gas production from the Cadotte and Falher C zones encountered in the subject well.

Approval to commingling Falher C “D” (Footwall) and Falher C “F” (Hangingwall) was granted to Burlington on September 14, 2004, which was amended on September 15, 2005. As noted in your application, this interim approval is intended to allow the acquisition of production test and pressure build-up data from the Cadotte zone. As noted in your application, gas compositions should be similar for these zones. Commingled production through the tubing is expected to increase reserves recovery from the Cadotte zone by mitigating liquid loading problems.

We wish to advise you that your application to commingle production from these zones is hereby granted **interim** approval, under the authority of section 41 of the *Drilling and Production Regulation*, subject to the following conditions:

1. Production from the Cadotte and Falher C formations may be commingled.
2. A supplementary application for commingled production, with supporting test data and gas analysis, must be submitted, with proposed allocation factors for production reporting.
3. AOF and reservoir pressure reports, based on available data, must be filed for each zone as per the requirements of sections 84 and 95 of the *Regulation*.
4. Formal approval for commingled production **will not** be authorized until all of the above listed conditions have been met.
