**RE: APPLICATION FOR COMMINGLED PRODUCTION (AMENDMENT #1)  
ARL NOEL b-56-J/93-P-1; WA# 14173**

The Commission has reviewed your application dated November 19, 2002 requesting an amendment to the commingled gas production approval granted July 8, 2002 to the Upper Gething, Middle Gething, Cadomin and Cadotte zones encountered in the subject well.

The Commission has now designated the gas pools under application to be Kelly – Gething “E”, Gething “F” and Cadomin “E”. No pool designation has been assigned to the Cadotte, as it appears to be non-productive at this time. Gas compositions for the three pools are very similar. Commingled completion is expected to increase the recoverable reserves from the three pools. Commingling of the Cadotte is considered appropriate, however, no production allocation can be assigned at this time.

We wish to advise you that your application to commingle production from the four zones is hereby approved, under the authority of section 41 of the *Drilling and Production Regulation*, subject to the following conditions:

1. Production from the Cadotte (2043.0-2046.0), Gething “F” (2485.0-2489.0 mKB), Gething “E” (2544.0-2549.0 mKB) and Cadomin “E” (2607.0-2614.0 mKB) pools may be commingled.
2. Gas, condensate and water production should be allocated on the Ministry of Provincial Revenue BC S-1 and BC S-2 forms on the basis of Gething “F” 17.5 %, Gething “E” 50.0% and Cadomin “E” 32.5%.
3. This approval may be modified at a later date if deemed appropriate through a change in circumstances.
