**RE: COMMINGLED PRODUCTION APPROVAL
PC DOMCAN JEDNEY a-44-J/94-G-1; WA# 13898**

The Oil and Gas Commission (OGC) has reviewed your application, dated August 9, 2001 requesting approval to commingle gas production from the Baldonnel and Halfway zones in the subject well.

The OGC has designated these gas pools as the Jedney Baldonnel/Upper Charlie Lake "A" and Halfway "A". On June 14, 2000 the OGC issued an interim approval to commingle these two zones, in order to establish reservoir pressure and AOF. Also, in order to improve gas recover, the OGC has previously approved commingled production from these same pools for a number of wells.

We wish to advise you that your application to commingle production from these pools is hereby approved, under the authority of section 41 of the *Drilling and Production Regulation*, subject to the following conditions:

1. Production from the Baldonnel/Upper Charlie Lake "A" and Halfway "A" pools may be commingled.
2. Gas, condensate and water production should be allocated on the Ministry of Energy and Mines BC S-1 and BC S-2 forms on the basis of Baldonnel/Upper Charlie Lake 50% and Halfway 50%.
3. This approval may be modified at a later date if deemed appropriate through a change in circumstances.
