The Oil and Gas Commission has reviewed your request dated December 26, 2001, for approval to commingle gas production from the Golata (3635.0 - 3665.0 mKB) and Debolt (3812.0 - 4119.0 mKB) zones in the subject well. Initial approval was granted via e-mail correspondence on December 27, 2001, from Jeff Johnson of this office. Initial approval is intended to allow the acquisition of addition supporting data for a formal application.

As noted in your application, gas compositions and reservoir pressures should be similar for the two zones. Commingled completion should allow the secondary Golata zone to be produced, thereby increasing well gas recovery. Both zones are on-target for gas production.

We wish to advise you that your application to commingle production from these pools is hereby granted interim approval, under the authority of section 41 of the *Drilling and Production Regulation*, subject to the following conditions:

1. A production test must be completed to establish the well AOF and reservoir pressure and reports filed as per the requirements of sections 84 and 95 of the *Regulation*.
2. A formal application for commingled production, with supporting log and test date must be submitted, with proposed allocation factors for production reporting.
3. This approval may be modified at a later date if deemed appropriate through a change in circumstances.
