IN THE MATTER of a Concurrent Production scheme with Good Engineering Practice (GEP) of Canadian Natural Resources Limited (CNRL) for producing the Weasel Halfway 'I' Pool without a project oil allowable.

NOW, THEREFORE, the Division Head, pursuant to section 97 of the Petroleum and Natural Gas Act (the Act), hereby approves a Concurrent Production project of CNRL for production of oil without an oil allowable and with a daily gas limit, as such project is described in

*an Application from CNRL to the Division dated April 18, 1997, and supplemented with additional information dated August 7, 1997.*

This scheme is approved, subject to the conditions herein contained and, in particular:

1. The area of the scheme shall consist of units 98 - 100 of Block J/94-A-15, units 8 - 10 and 20 of Block B/94-H-2 and units 1 and 11 of Block C/94-H-2.
2. The project oil allowable is waived.
3. Gas production from oil wells within the scheme is limited to  $45 \text{ e}^3 \text{ m}^3/\text{d}$ .
4. All gas produced must be conserved.
5. An oil well may be drilled anywhere within the project area provided that it is not completed nearer than 100 m to the sides of the approved area.
6. This approval may be modified or rescinded at a later date if deemed appropriate.
