**RE: CONCURRENT PRODUCTION SCHEME APPLICATION  
BEAR FLAT - BEAR FLAT "B" and "D" OIL POOLS**

The Commission has reviewed your application dated July 17, 2003 requesting Concurrent Production scheme approval for the Bear Flat - Bear Flat "B" oil pool.

The Commission has carried out a technical review of the pool. Based on this review, the Bear Flat "B" pool has been split into two single well pools. The well A7-29-84-20 W6M remains in the Bear Flat "B" pool whereas the well 7-20-84-20 W6M is now mapped as the Bear Flat "D" pool.

As the Bear Flat "D" pool is of a limited size, your request for Concurrent Production scheme approval is justified. However, pool mapping and performance indicates that the Bear Flat "B" pool is not fully delineated. The Commission feels that sufficient information is not yet available to grant Concurrent Production approval at this time.

Therefore, for the Bear Flat "D" pool, Approval 03-07-006 is hereby granted under section 97 of the Petroleum and Natural Gas Act. Please note that this approval is not effective until the date that gas is conserved, with OGC notified in writing. (Effective 2004/03/17)

IN THE MATTER of a Concurrent Production scheme of Devon Canada Corporation (Devon) for producing the Bear Flat - Bear Flat "D" pool with a project gas and oil allowable.

NOW, THEREFORE, the Commission, pursuant to Section 97 of the Petroleum and Natural Gas Act, hereby approves the Concurrent Production scheme of Devon for oil and gas production with project allowables, as such scheme is described in

*an Application from Devon to the Commission dated July 17, 2003 and related submission.*

This scheme is approved, subject to the conditions herein contained and, in particular:

1. The area of the scheme shall consist of sec 20-84-20 W6M.
2. The project daily oil allowable is 10 m<sup>3</sup>.
3. Gas production will be limited to 5.0 10<sup>3</sup> m<sup>3</sup>/d.
4. All produced gas must be conserved.
5. The requirements of Section 9 of the *Drilling and Production Regulation* are hereby waived, provided that oil wells within the scheme area are not completed nearer than 100 m to the sides of the approved area.
6. This approval may be modified or rescinded at a later date if deemed appropriate.
