**RE: CONCURRENT PRODUCTION APPROVAL (AMENDMENT #1)
STODDART NORTH PINE "F" POOL**

Attached is an amended Concurrent Production scheme approval for a portion of the subject pool as requested in your application dated September 29, 1998.

The Approval 98-07-003 (Amendment #1) is hereby granted under section 97 of the Petroleum and Natural Gas Act.

Condition #3, the gas production limit, has been made an annual allowable volume to offer operational flexibility. This amendment becomes effective November 1, 1998, the beginning of the new production year. Any gas overproduction will be used to reduce the following year's annual volume.

The Branch has not yet received any evidence from the pool operators regarding the feasibility of a secondary production scheme for this pool. The deadline for submission of such a study is March 1, 1999. Following this date, reservoir performance data will be reviewed and this approval may be modified or rescinded, as per condition #5.


IN THE MATTER of a Concurrent Production proposal of Petro-Canada Oil and Gas (Petro-Canada) for producing a portion of the Stoddart North Pine "F" Pool with a project oil and gas allowable.

NOW, THEREFORE, the Commission, pursuant to section 97 of the Petroleum and Natural Gas Act (the Act), hereby approves an amendment to the Concurrent Production project of Petro-Canada for oil and gas production with project allowables, as such project is described in

an Application from Petro-Canada dated March 5, 1998, and September 29, 1998 and related submission.

This project is approved, subject to the conditions herein contained and, in particular:

1. The area of the project shall consist of N/2 Section 1-86-19 W6M.
2. The project oil allowable, based on the sum of the individual wells, is 20.0 m³/d.
3. The project gas production is limited to an annual allowable volume of 2591.5 10³m³.
4. All associated gas production must be conserved.
5. This approval may be modified or rescinded at a later date if deemed appropriate.
