**RE: GOOD ENGINEERING PRACTICE APPROVAL
GRAHAM - BALDONNEL "D" POOL**

The Commission has reviewed your applications, dated January 9, 2004, for Good Engineering Practice (GEP) scheme approval for gas development, titled South Graham (East) and South Graham (West) – Baldonnel pool.

The Commission has conducted a geologic review of the Baldonnel formation in the area of application. As a result, our interpretation remains that the subject pool is a single non-associated gas pool, Graham – Baldonnel "D".

The Approval 04-06-016 is hereby granted under Part 8, Division 6, Section 101 of the British Columbia *Drilling and Production Regulation*. The area of approval includes the two contiguous requested land blocks.

This approval will allow the drilling of higher density gas wells, without regard for spacing and target regulations in order to optimize pool drainage and recovery.

IN THE MATTER of a Good Engineering Practice (GEP) scheme of Anadarko Canada Corporation (Anadarko) for producing gas wells from the Graham - Baldonnel "D" pool without well spacing and target restrictions.

NOW, THEREFORE, the Commission, pursuant to Part 8, Division 6, Section 101 of the *Drilling and Production Regulation*, hereby approves the GEP scheme of Anadarko for drilling wells without spacing and target restrictions, as such scheme is described in

an Application from Anadarko to the Commission dated January 9, 2004.

This scheme is approved, subject to the conditions herein contained and, in particular:

1. The area of the scheme shall consist of:

94-B-8


Block F - Units 56, 57, 66, 67, 72-79, 82-89, 92-99

Block K - Units 2-9, 16-19, 26-29, 36-39, 46-49.

2. The requirements of Section 10 of the *Drilling and Production Regulation* are hereby waived, provided that gas wells within the scheme area are not completed nearer than 250 m to the sides of the approved scheme area.

3. The gas wells within the scheme area may be produced without individual well allowable restrictions.

4. This approval may be modified or rescinded at a later date if deemed appropriate.
