FIREWEED – DOIG “C” POOL**



IN THE MATTER of a Good Engineering Practice (GEP) scheme of Bonavista Petroleum Ltd. (Bonavista) for producing the Fireweed – Doig “C” gas pool without spacing or target restrictions.

NOW, THEREFORE, the Commission, pursuant to Part 8, Division 6, Section 101 of the *Drilling and Production Regulation*, hereby approves the GEP scheme of Bonavista as such scheme is described in

an Application from Bonavista to the Commission dated July 27, 2006 and related submissions.


This scheme is approved, subject to the conditions herein contained and, in particular:

1. The area of the scheme shall consist of :

94-A-13:

Block A – units 36, 37, 46, 47, 56, 57, 66 and 67.

2. The requirements of Section 10 of the *Drilling and Production Regulation* are hereby waived, provided that gas wells within the project area are not completed nearer than 250 m to the sides of the approved project area.
3. The gas wells within the project area may be produced without individual well allowable restrictions.
4. This approval may be modified or rescinded at a later date if deemed appropriate.
