IN THE MATTER of a Good Engineering Practice (GEP) scheme of Pengrowth Corporation (Pengrowth) for producing a portion of the Doig Rapids Nordegg-Baldonnel "A" pool gas without well spacing and target restrictions.


NOW, THEREFORE, the Commission, pursuant to Part 8, Division 6, Section 101 of the *Drilling and Production Regulation*, hereby approves the GEP scheme of Pengrowth for drilling wells without spacing and target restrictions, as such scheme is described in

an Application from Pengrowth to the Commission dated January 7, 2004.

This scheme is approved, subject to the conditions herein contained and, in particular:

1. The area of the project shall consist of:

94-A-16 Block K - units 16, 17, 26 and 27.
2. The requirements of Section 10 of the *Drilling and Production Regulation* are hereby waived, provided that gas wells within the project area are not completed nearer than 250 m to the sides of the approved project area.
3. Gas production from the scheme area must be restricted to a daily gas allowable of $60.0 \times 10^3 \text{m}^3$.
4. This approval may be modified or rescinded at a later date if deemed appropriate.
