GOOD ENGINEERING PRACTICE SPECIAL PROJECT, AMENDMENT #1
OTHER THAN NORMAL SPACING ORDER, AMENDMENT #1
HERITAGE – MONTNEY "A" POOL

The Commission has reviewed your application dated November 8, 2011, requesting amendment of a Good Engineering Practice approval for the Heritage field – Montney formation.

The Commission maps this area within the regional Heritage field - Montney "A" pool. Gas recovery from this resource will benefit from the ability to produce horizontal wells in optimal locations, drilling from central sites. For regulatory purposes, the Commission designates the entire Montney sequence as a single formation, removing commingling as an issue.

The following Orders are attached;

- 1) Order 09-06-018 (Amendment #1) designating Good Engineering Practice, within a portion of the Heritage field Montney "A" pool as a Special Project under section 75 of the Oil and Gas Activities Act, and
- 2) Order 09-06-018-OTN (Amendment #1) approving Other Than Normal Spacing under section 65.1 of the *Petroleum and Natural Gas Act* for the subject pool and area.

As a Good Engineering Practice special project, the applicant intends to locate, complete and operate wells in a manner to optimize resource recovery while minimizing surface impacts. The target area for the project boundaries has been reduced to **150m** (from 250m) as a result of this amendment. Due to changes in tenure, the approval has transferred from Monterey Exploration Ltd. to Pengrowth. The approval area remains unchanged.

ORDER 09-06-018-OTN (Amendment #1)

1 Under Section 65.1(2) of the *Petroleum and Natural Gas Act*, Other Than Normal Spacing is approved within the Heritage field Montney formation within the following area;

DLS 80-20W6 – Section 19 DLS 80-21W6 – Sections 13, 25, 35 DLS 81-21W6 – Section 1.

- 2 Under section 65.1(3) of the *Petroleum and Natural Gas Act*, I specify the following:
 - a) the target area for a gas well completed within the project area is not nearer than 150 m to the sides of the Other Than Normal Spacing area,
 - b) a gas well completed outside the specified target area may be subject to an off-target production penalty,
 - c) gas wells drilled within the specified project area are not subject to spacing requirements.
