RE: GOOD ENGINEERING PRACTICE (GEP) APPROVALS BOUNDARY LAKE – GETHING "A"

PETITOT RIVER - SLAVE POINT "A"

It has come to the attention of Commission staff that the GEP approvals granted for the subject pools, March 26, 1975 and December 14, 1973 respectively, may no longer be appropriate.

BOUNDARY LAKE - GETHING "A"

The GEP area of section 10-85-14 W6M encompasses the gas spacing area for the well PEX et al Boundary 12-10-85-14 (WA# 352). All Gething gas production from the approved area has ceased and the Gething zone in this well was abandoned on February 22, 1999.

PETITOT RIVER - SLAVE POINT "A"

The GEP area of units 14, 15, 24 and 25 of Block D/94-P-13 encompasses a gas spacing area shared by two wells; PEX Petitot d-24-D/94-P-13 (WA# 403) and PEX Petitot d-14-D/94-P-13 (WA# 3427). All Slave Point gas production from the approved area has ceased and the Slave Point zone in these wells was abandoned in March 1997.

Attached are copies of the original approvals. Prior to rescinding these approvals, the OGC hereby requests written comment from Petro-Canada Oil and Gas on the impact this may have on any future development plans.
