IN THE MATTER of a Good Engineering Practice (GEP) scheme of Pioneer Natural Resources Canada Inc. (Pioneer) for producing Wargen Baldonnel "B" gas wells without spacing and target restrictions.

NOW, THEREFORE, the Oil and Gas Commission (Commission), pursuant to Part 8, Division 6, Section 101 of the *Drilling and Production Regulation*, hereby approves the GEP scheme of Pioneer as such scheme is described in

an Application from Pioneer to the Commission dated October 20, 2004.

This scheme is approved, subject to the conditions herein contained and, in particular:

1. The area of the project shall consist of:
94-H-6 Block B – units 18, 19, 28 and 29.
2. Gas production is limited to a daily gas allowable of $60.0 \text{ e}^3\text{m}^3/\text{d}$.
3. The requirements of Section 10 of the *Drilling and Production Regulation* are hereby waived, provided that gas wells within the scheme area are not completed nearer than 250 m to the sides of the approved project area.
4. This approval may be modified or rescinded at a later date if deemed appropriate.
